

ORDINANCE NO. 3652

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF CUMBERLAND, ENTITLED "AN ORDINANCE TO ENACT SECTION 15-54 OF THE CODE OF THE CITY OF CUMBERLAND ENTITLED 'PARKLET CLOSURE' PROVIDING FOR CLOSURE TIMES FOR CERTAIN PARKLETS WITHIN THE CITY OF CUMBERLAND."

WHEREAS, the Mayor and City Council of Cumberland owns certain parklets within its municipal boundaries;

WHEREAS, those parklets include the following:

1. Heritage Parklet (15 Baltimore Street - located at the corner of Baltimore and Canal Streets - identified as Tax Account No. 04-035720);
2. Gateway Parklet (32 Baltimore Street - located at the corner of Baltimore and Mechanic Streets - identified as Tax Account No. 14-004734);
3. Hospitality Parklet (70 Baltimore Street - located at the corner of Baltimore and Liberty Streets - identified as Tax Account No. 14-003606); and
4. Maze Parklet (23 North Centre Street - located between The Book Center and Ottaviani's Restaurant - identified as Tax Account No. 14-003517);

WHEREAS, the Mayor and City Council of Cumberland has determined that it is in the City's best interests to close these parklets between the hours of 11:00 p.m. through 7:00 a.m. for the purpose of deterring vandalism, criminal activity and excessive loitering and for the purpose of cleaning the parklets so as to preserve the integrity or

the artwork and structures at and on the parklets, their cleanliness, and their availability for the public to enjoy on a more all-inclusive basis.

NOW THEREFORE:


SECTION 1: BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF CUMBERLAND, that Section 15-54 of the Code of the City of Cumberland (1991 Edition) be and is hereby enacted. It shall read as follows:

**Sec 15-54. Parklet Closure.**


The following parklets shall be closed between the hours of 11:00 p.m. and 7:00 a.m.: (1) Heritage Parklet located at 15 Baltimore Street; (2) Gateway Parklet located at 32 Baltimore Street; (3) Hospitality Parklet located at 70 Baltimore Street; and (4) Maze Parklet located at 23 N. Centre Street. Notwithstanding the foregoing, the City Administrator shall have the authority extend the hours any or all of the parklets may remain open for special events.

SECTION 2: AND BE IT FURTHER ORDAINED BY THE MAYOR AND CITY COUNCIL OF CUMBERLAND, that this Ordinance shall take effect from the date of its passage.
